that has a greater than 50% likelihood of being realized upon ultimate settlement.
Management believes that there were no potential sources of unrelated business taxable
income subject to tax for the years ended June 30, 2022 and 2021. Accordingly, no
provision for income taxes has been made. The School files its forms 990 in the U.S.
federal jurisdiction and the office of the state's attorney general for the State of
Maine. The School is generally no longer subject to examination by the Internal Revenue
Service for years before 2019.
