- a. Charter Commission meeting update Dick Durost asked about parallel reporting requirements. Torey asked if it was possible to have fewer than five years in a renewal plan. Gina said no. Gina said the commission could intervene and withdraw their authorization if necessary. Gina was elected interim executive director of the Charter Commission. Wilson Hess elected Chair. Nicki Farnham elected Vice Chair. MEANS was approved for a five-year renewal with a 4-1-1 vote. Tori Kornfield voted no. Thomas Keller abstained. The Harpswell vote was postponed until the next meeting while awaiting documentation. Dick spoke with Steve Bailey to inquire about having charter schools be part of the Maine School Management system. Access is likely to be granted to charter school administrators in the near future.
- b. Nominations and election of officers Drew facilitated an active discussion and presented nominations of the governance committee: Sherry Gilbert, President; Dick Durost, Vice President; Linda Warner, Secretary; Drew Landry, Treasurer.

c. Announcement of Dean of Students - Jasen Richardson is the new Dean of Students. Alex Savage, an Apple certified technician, is the new IT specialist. He started working part time Monday, August 1, 2022. A new math teacher and a new school nurse have also been hired.
