- **a.** Guest Carter Houle. Carter was introduced to the Board and guests by Tina Spencer. Carter graduated in 2021 as an approved early graduate. Carter spoke of his trouble in traditional high schools and announced that he had just graduated from an accelerated program at Universal Technical in PA. He said that it would not have been possible if it wasn't for MeAA and the teachers and staff. He specifically credited Mrs. Spencer, Ms. Veillieux, Mr. Herman and Mrs.King.
